- 2) Attestation of Compliance: Please affirm that, if selected as a Member of the Board of Directors, that you would at all times seek to uphold the objectives of the GLEIF as set out in the Statutes and seek to ensure the operation of the GLEIF in the broad public interest in line with the High Level Principles and FSB recommendations that are available in an annex of the GLEIF Statutes on www.gleif.org (see Statutes Annex 1 Charter ROC Annex A Global LEI System High Level Principles).
