

Highlights

During the reporting period of April 2022, GLEIF has strengthened its data quality requirements and introduced additional 34 new and updated 40 data quality checks. The set of defined data quality criteria is now completely covered, with two of the new checks describing the outstanding quality criterion - Timeliness. This improvement was triggered to support the three newly implemented ROC policies. Increasing the requirements for the data led to a decrease in the Average Total Data Quality Score to 99.77 and the number of LEI Issuers achieving Required Data Quality to 23. By the end of the current reporting period, a positive trend of the Total Quality Score reaching 99.82 was already observed.
