
Summary




Highlights

In April, the Total Data Quality Score remained consistent at 99.99%, reflecting continuous performance in maintaining high data standards. The report also indicates an enhancement in Accessibility and Representation quality criteria. The number of LEI issuers achieving Required, Expected, and Excellent Data Quality slightly decreased compared to the previous reporting period. Additionally, the Average Days to Close a Challenge has improved to 28 days over the past month.
