# Global LEI Data Quality Report | August 2023



### Summary



### Highlights

In the reporting period of August 2023, the Average Total Data Quality Score slightly dropped in between but elevated to 99.87 at the end. The number of LEI issuers achieving Expected and Excellent Data Quality has improved significantly compared to the previous month. While there was a brief uptick in the failure rates for checks C000309 and C000245 related to the accuracy and consistency of relationship information, it's worth highlighting that these issues were addressed swiftly by the LEI issuing organization within the same month. The Average Days to Close a Challenge has now reached three days.
