Summary




Highlights

The assessment of December 2022 shows a steady Total Data Quality Score of 99.97. In the last month of the year, the number of LEI Issuers achieving Required, Expected, and Excellent Data Quality improved back to the levels of the previous reporting periods.

Compared to previous years, 2022 exhibits stable values of the Average Total Data Quality Score (99.93) and Average Days to Close a Challenge (6). Throughout the year 2022, a significant increase of the LEI Issuers achieving higher Maturity Levels is recorded in the Global LEI System: on average, 23 organizations achieved Expected and Excellent Quality.
