
Summary

Highlights

In December 2023, the Total Data Quality Score held steady at 99.99, reflecting a stable performance. Notably, 35 out of 37 LEI issuers achieved the Required Data Quality. Meanwhile, 18 LEI issuers consistently met all requirements for Expected and Excellent Data Quality. 2023 shows an improvement of 0.03 in Average Total Data Quality (99.96), with stable Maturity Levels. Introducing the extended Challenge Facility enhanced the handling of bulk challenges and automated the processing of external data for legal entity events. While increasing processing time, it ultimately elevated the accuracy and timeliness of LEI data.
