Highlights

GLEIF launched the 2025 Rule Setting Consultation on 3 July, reaffirming its commitment to greater standardization, reliability, and transparency within the Global LEI System. The initiative fosters close collaboration with LEI issuers to drive continuous improvement. Notably, one of the Top 5 Failing Checks, C000438, saw a significant drop in average failures, from 64 to 22, compared to the previous reporting period. This reflects measurable progress in data quality enhancement over time.
