
## Summary




#### Highlights

In the June 2023 assessment, the Total Data Quality Score remained steady at 99.99. The number of LEI issuers meeting Required Data Quality increased to 37, while those achieving Expected and Excellent Data Quality slightly decreased. The Average Days to Close a Challenge normalized to 4 days. In early June, GLEIF introduced a new extension to its challenge facility, enabling efficient handling of large volumes of challenges and thereby improving data quality. Currently, GLEIF and LOUs are exploring the new functionality focusing on topics such as consistency between language tags and the actual content in the data elements.
