

Highlights

In the reporting period of May 2022, the Average Total Data Quality Score increased further by 0.07 to 99.84. Maturity Level 1 has been achieved by 26 LEI Issuers, while the number of LEI Issuers reaching Maturity Level 2 and 3 slightly declined compared to April 2022. The Top 5 Failing Checks showcase that LEI Issuers are actively resolving data quality issues. We observe a decrease in the average number of check failures related to entity ID patterns and validation authorities for funds. The reporting period was very active regarding challenges.
