


Average Days to Close a Challenge | compared to the previous month

### Highlights

In the reporting period of October 2023, the Average Total Data Quality Score improved further to 99.99. The number of LEI issuers achieving Required, Expected, and Excellent Data Quality has remained similar to the previous month. The average days to close a challenge have slightly increased due to a significantly higher number of challenges raised, focusing on relationship information and legal entity events.
