

Highlights

The assessment of September 2022 shows a continued increase in the Total Data Quality Score, now reaching an average of 99.95. Compared to the previous reporting period, 31 LEI Issuers showed Required Data Quality; of these, 21 LEI Issuers achieved Excellent and Expected Data Quality. Throughout September, the Average Days to Close a Challenge have improved to four. Furthermore, Data Quality Check Failures related to entity ID patterns declined by 81.50% compared to the previous reporting period.
