


#### **LEI Total Data Quality Score**

Progress achieved with regard to the continuous optimization of the data quality based on the LEI Total Data Quality Score



The data quality assessment performed on 31 December 2016 shows that, the majority of LEI issuers now ensure required and expected data quality for the second consecutive month. During the past year, advances were seen in both the rigor of GLEIF's data quality rule setting, as well as the ability of LEI issuers to conform to these new standards.


