Summary




Highlights

The assessment of December 2021 shows the number of LEI Issuers achieving Required Quality remains stable above 90%, and more than 50% of LEI Issuers continue reaching Expected or Excellent Quality. The Total Data Quality Score continues its positive trend from the past months, and the average for this reporting period reached 99.97. This trend is reflected in the improved values for the quality criteria: Accuracy, Comprehensiveness, and Provenance. Predominantly, the accuracy of reporting exceptions and relationship records has improved, covered by check C000309. The average days to close a challenge further improved to 3 days.
