

Global LEI Data Quality Report | January 2017

Data Quality Scores





Summary

The assessment performed on 31 January 2017 shows that the data quality of the LEI population has improved with regard to the criteria 'Integrity', 'Representation', 'Uniqueness' and 'Validity' over the past year. Two of the five LEI issuers that have achieved the highest level of data quality in the last 12 months manage more than 40,000 LEIs, respectively.

The Data Quality criteria is expected to contain 12 dimensions. Currently a subset of 7 criteria is implemented, to the detriment of the score, as they are averaged on all of them. This is expected to change, on a nonfixed timeline, to include all 12 dimensions.
