
# **Summary**




### Highlights

For the assessment of June 2021, GLEIF introduces an enhanced calculation for the presented measures and a new layout of the Data Quality reports. By using daily data, the latest reports now showcase time series of the calculated values for the current reporting period and the previous two periods. GLEIF now focuses the monitoring on three key metrics: Total Data Quality Score, LEI Issuers achieving Expected Data Quality, and Average Days to Close a Challenge. Based on the new underlying calculation methodology, more than 30% of the LEI Issuers reached Expected and Excellent Data Quality, while 77% achieved at least Required Data Quality.
