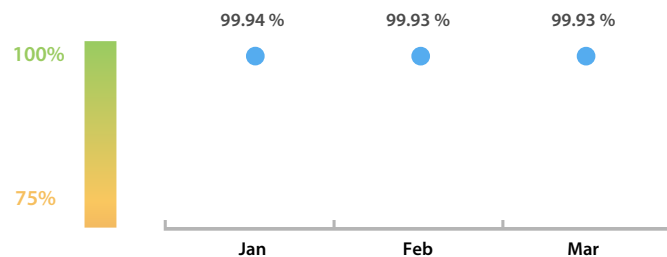
LEI Issuer Total Data Quality Score

The LEI Issuer Total Data Quality Score is calculated as the equal weighted average of the 11 'Data Quality Criteria'.

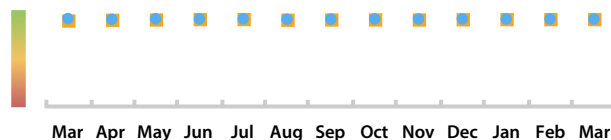


LEI Issuer Total Data Quality Score Trend
