The LEI Total Data Quality Score is calculated as the equal weighted average of the 11 'Data Quality Criteria' listed below.



Summary

The assessment conducted on 31 March 2020 shows the highest number of LEI issuers (32 out of 34) achieving the required data quality, since the introduction of the monthly data quality reporting. In the past quarter we observed a lower number of challenges raised. GLEIF's centralized challenge facility extends the ability to trigger updates of LEI data and relationship information to all interested parties.
