


Highlights

The assessment of November 2021 shows improvements in all three key metrics. The Total Data Quality Score continued to increase, and the average value for this reporting period is again above the 99.90 mark (99.91). LEI Issuer achieving Expected and Excellent Data Quality further improved to 56% and 54%, respectively. Corresponding to the improved Maturity Level performance, the average number of check failures declined as well. In average the processing time to close a challenge decreased from seven to five days.
