#### **LEI Total Data Quality Score**

The LEI Total Data Quality Score is calculated as the equal weighted average of the 11 'Data Quality Criteria' listed below.



#### Summary

The assessment performed on 31 October 2018 shows that all LEI issuers successfully passed checks against the data quality criteria 'Representation' and 'Comprehensiveness'. Overall performance by the individual LEI issuers further improved. The lowest data quality score for an individual LEI issuer is now slightly above 99%.
