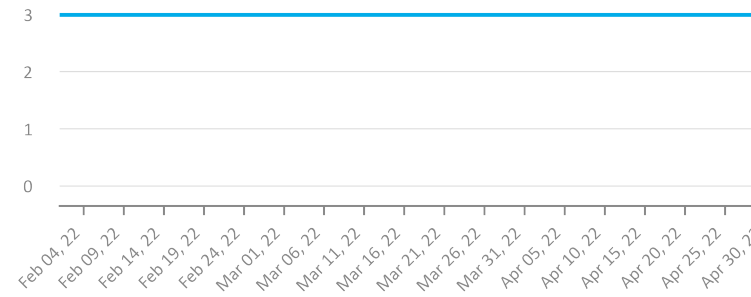

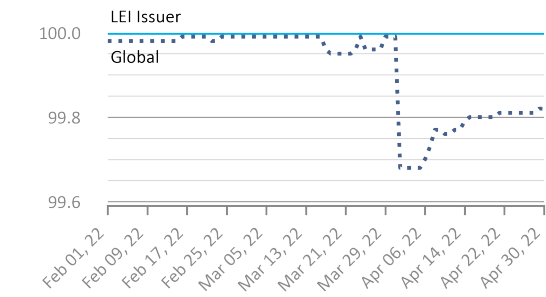

Maturity Level Trend

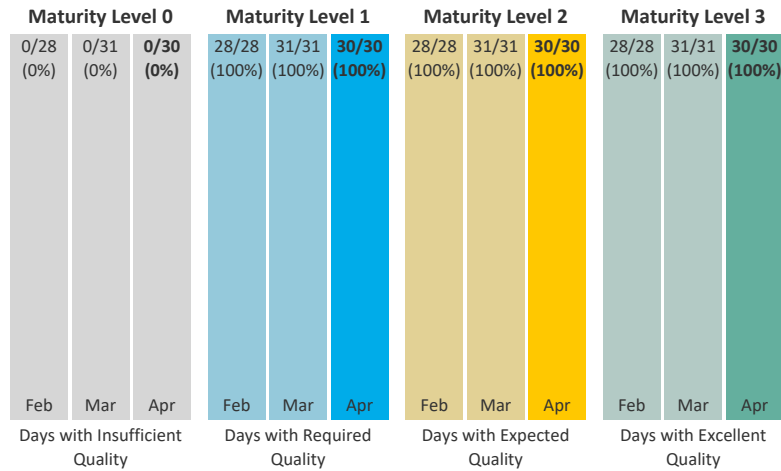


Total Data Quality Score Trend
