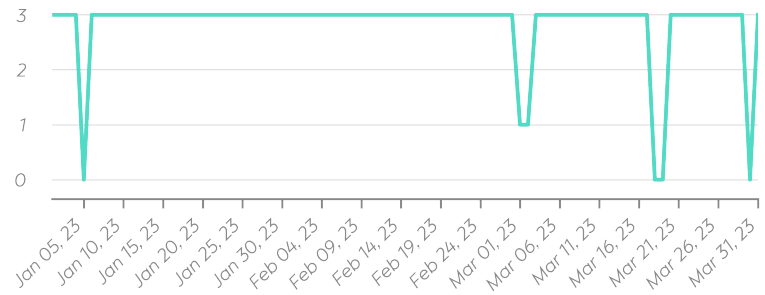

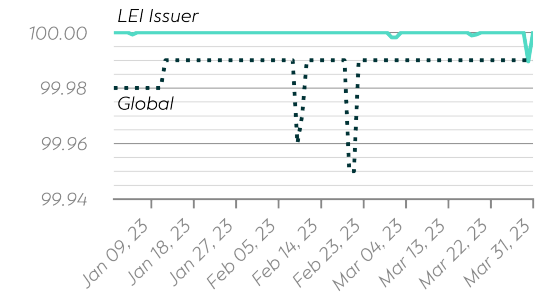

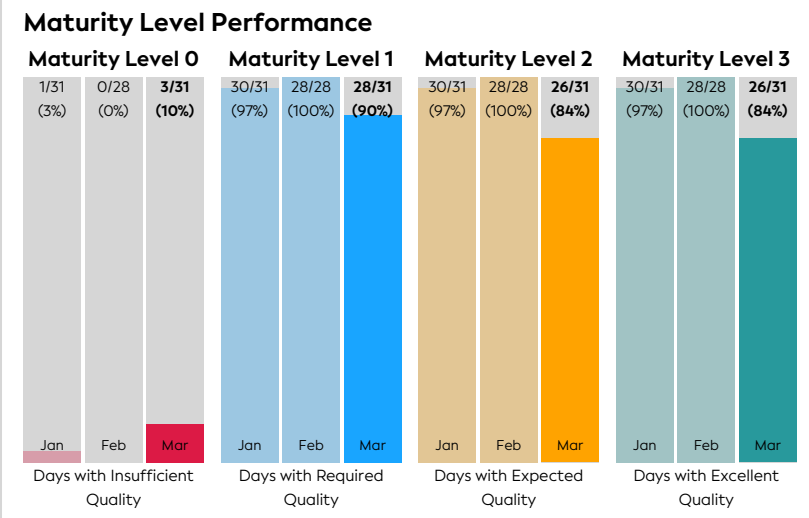
Maturity Level Trend
