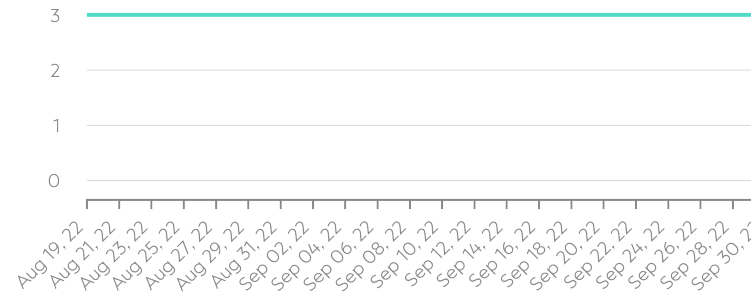

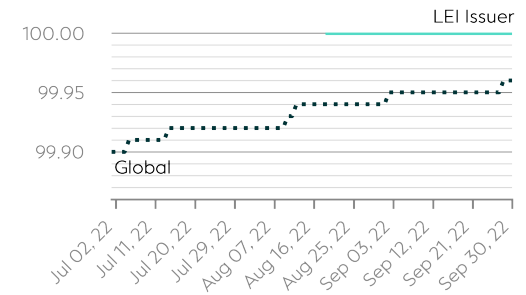

#### Maturity Level Trend

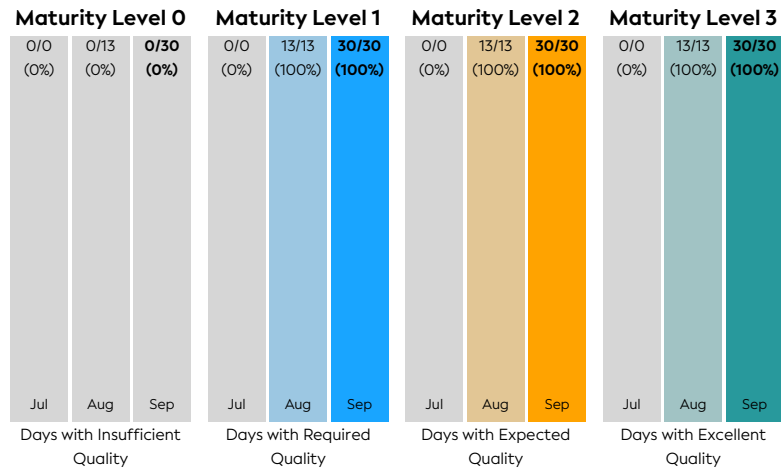

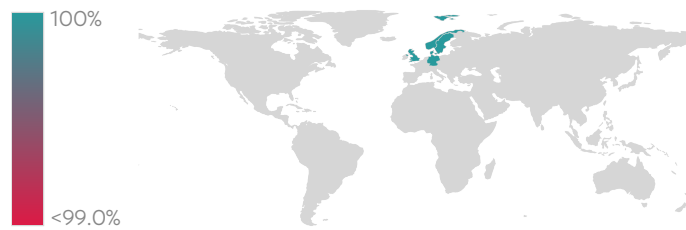
